TUITION, FEES, AND FUNDRAISING OBLIGATION INFORMATION
FOR THE 2011/2012 SCHOOL YEAR**

Tuition

Tuition for the 2011/2012 school year is **\$8,150** payable over a maximum of 11 months. The first tuition payment is due by July 1, 2011. Subsequent payments are due the 1st of each month with the final payment due by May 1, 2012. Several payment options are available and explained on the accompanying tuition contract. **The 11-month payment option will require an automatic payment from a bank account.** See the Payment Options section on the following page.

Registration Fee

A non-refundable registration fee of **\$250** is due by Registration Day, March 5, 2011. The fee is used to defray the costs associated with registration, course selection, and tuition account management. The fee also provides students with free admission to all home athletic events, Student ID and yearbook photos, Student Directory, Program of Studies, The Lakeline (student newspaper), The Forum (literary magazine), The Torch (yearbook) and Student-Parent Handbook (with agenda).

Participation Fees

Participation fees help to offset the costs of transportation, officials, uniforms and equipment for each activity. The fee is added to the tuition account at the beginning of each season. To encourage our students to participate in more than one sport and to ease the financial burden on parents with more than one athlete, the participation fees per family will not exceed \$800 per year (hockey and band camp fees are excluded from the family cap of \$800).

Transportation Fee

Van transportation fees are assessed to those students needing transportation to and from school. Lake Catholic owned and operated vans pick up and return students to various locations throughout Lake, Cuyahoga, and Geauga counties. The fees for this transportation vary based on the service selected. Please see the transportation registration flyer for more information.

Course Fees

Although there are no fees added to tuition for enrolling in specific courses, there may be some additional costs incurred due to the nature of the course. For example, students enrolled in religion classes are required to buy their own textbooks. Certain courses may require students to purchase a workbook that corresponds to the text, and students in art or fashion design classes may be asked to purchase various supplies for the class. All students enrolled in AP classes will be required to take the corresponding AP Exam at a cost of approximately **\$90** each.

Other Fees

The cost of bank charges incurred by Lake Catholic for checks or electronic payments returned for insufficient funds will be assessed to tuition accounts. Tuition accounts will be assessed a fee of \$25 each month the balance of the account remains delinquent.

All-School Fundraiser Requirement

Each student is **required** to sell **\$100** worth of car raffle tickets during the last two weeks of August and first two weeks of September. Each family will receive a book of ten, \$10-tickets to purchase or sell. The proceeds from the auto raffle assist in defraying the cost of athletics and all other co-curricular programs.

Calculation of Monthly Payments: If you choose the 11-monthly payment option, your monthly payments will equal 1/11th of the cost of tuition plus transportation fees, minus applicable discounts, tuition assistance granted, and any scholarships your son or daughter are awarded. All monthly payments are due on the 1st of the month beginning in July 2011 and ending in May 2012. Participation fees are payable in full by the end of the semester in which they are assessed. Tuition assistance and scholarships are awarded on a semester basis only and are revoked if a student leaves the school for any reason before the school year ends. Please call Lake Catholic's Business Office with any questions on calculating your monthly payment.
