Lake Catholic High School offers four tuition payment plans. Please choose one of the following:

_____ Payment-in-Full. Full payment made by June 30, 2021 qualifies for a 2% early-payment discount; otherwise the due date is no later than July 20, 2021. If full payment cannot be made by this date, we ask that you call the business office to make other arrangements and possibly select another payment option.

_____ Semester Payments. Payments made by June 30 and December 30, 2021 each qualify for a 1% early payment discount; otherwise semester payments are due no later than July 20, 2021 and January 20, 2022. If your semester payments cannot be made by these dates we ask that you call the business office and to make other arrangements and possibly select our monthly payment option.

_____ Payments Over 11 Months; July through May. This plan requires providing a bank account from which we will directly withdraw your payment(s) each month. Payment dates are the 1st and 20th of each month or both. **If you are currently making your payments in this manner, we will continue to use the same date(s) and bank information.** If you are new to this payment plan, please complete an *Automatic Payment Plan Enrollment Form*. Note: payment(s) will also be withdrawn in June 2022 for accounts that are not paid-in-full at that time.

_____ Tuition Financed through the Cardinal Community Credit Union. This option allows for direct payment by cash, check, or ACH and offers more flexibility on payment dates. Contact Rachel Walker at 440-266-2231.

Calculation of Payments: The first statement for each school year will be emailed around June 20th, prior to the start of the school year. Your payment amount will be calculated based on the outstanding balance on this statement. This statement will reflect tuition for the coming school year and any fees that are known at that time. This statement will also reflect any *Tuition Assistance* that has been awarded by Lake Catholic High School and the Diocese of Cleveland, as well as any additional scholarships or grants known at that time (academic scholarships, multi-student grant, alumni grant, etc.). Please review this statement carefully and call the Business Office at 440-578-1020 if you have any questions.

- If you are paying in full, mail your payment (payable to Lake Catholic High School) for the full outstanding balance on this statement to the Business Office by July 20, 2021. If you make your payment by June 30th please subtract a 2% early-payment discount from your payment.
- If you are paying by semester, divide the outstanding balance in half and mail the payment (payable to Lake Catholic High School) to the Business Office by July 20, 2021. If you make your payment by June 30th, please subtract a 1% discount from your semester payment. The remaining account balance will be due by January 20, 2022 with an additional 1% discount for paying by December 30, 2021.
- If you are paying monthly, divide the outstanding balance (**which includes unpaid charges from previous years**) by 11. This is the amount that will be withdrawn directly from your bank account each month. This monthly amount will be divided in half if you choose to utilize both payment dates of the 1st and the 20th. The monthly payment(s) withdrawn will not be adjusted for additional fees assessed or payments made without your prior approval, verbal or written.
- Payment plans can be changed by calling the Business Office.

Tuition and Fees

Lake Catholic announces the tuition to be charged for its next school year by March 1st each year. Information pertaining to tuition can also be found on Lake Catholic's web site and in Lake Catholic's Parent/Student Handbook which is distributed prior to the start of each school year.

Students are assessed a registration fee every year to cover the cost of registration, course selection, technology, home sporting events, etc. and to secure the student's place in their chosen classes. This is a non-refundable fee of \$350 for new students and \$250 for continuing students must be paid at the time of registration/course selection.

Additional fees are billed as incurred. A schedule of fees can be found in the Parent/Student Handbook which is distributed prior to the start of each school year. These fees include, but are not limited to: athletic participation fees, testing fees, graduation fees, etc. Participation fees are capped at \$1,200 per family not including fees not paid directly to Lake Catholic. Participation fees are payable in full by the end of the semester in which they are invoiced. Please call the Business Office if you would like your participation fees factored into your monthly payment amount.

I understand that account delinquency may result in the holding of schedules, grades, and transcripts and the forfeiture of prom, graduation, and future registration privileges.

GOVERNING LAW: The parties hereto agree that all actions or proceedings arising in connection with this Agreement shall be tried and litigated exclusively in the State and Federal courts located in the County of LAKE, State of OHIO. The aforementioned choice of venue is intended by the parties to be mandatory and not permissive in nature, thereby precluding the possibility of litigation between the parties with respect to or arising out of this Agreement in any jurisdiction other than that specified in this paragraph. Each party hereby waives any right it may have to assert the doctrine of forum non conveniens or similar doctrine or to object to venue with respect to any proceeding brought in accordance with this paragraph, and stipulates that the State and Federal courts located in the County of Lake, State of Ohio, shall have in personam jurisdiction and venue over each of them for the purpose of litigating any dispute, controversy, or proceeding arising out of or related to this Agreement.

By signing below, each signator represents that the information provided herein is accurate; that each will be jointly and severally liable for all sums due Lake Catholic High School whether now existing or hereafter accruing as it relates to the Student identified above; and that this contract was executed in Lake County in the State of Ohio.
