Lake Catholic High School has partnered with Cardinal Credit Union on the SmartStart Lake Catholic High School Branch initiative. In addition to operating one of the first student-run branches in Northern Ohio, the partnership is providing a disciplined financial literacy program designed to develop responsible money management skills in high school—a far better approach than learning the hard way by making costly financial mistakes in the real world of college and young adulthood.

We encourage all students to open a free checking account for use at the student branch. Regular use of the branch will be coupled with significant opportunities for financial education in group presentations in the classroom and in individual conversations with branch staff.
